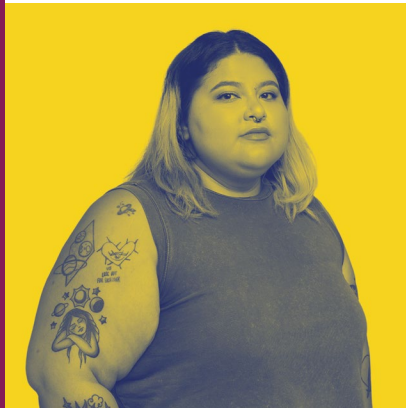

And, in those 21 months, I have never been more inspired by how our staff, volunteers, and donors have shown up in the face of unrelenting attacks on sexual and reproductive health care. The hurdles we face only strengthen our resolve and commitment to continue providing essential health care services to our patients.

We are proud abortion providers in states where abortion care is legal, and Planned Parenthood proudly offers so much more for our patients and communities. We are a lifeline for so many who rely on us for high-quality, affordable health care and information they can trust.

From contraception to cancer screenings, annual wellness visits, gender-affirming care, STI testing and treatment, menopause services, and much needed education and support services, we have continued to show up for our patients. And we have even expanded services, now offering vasectomy in Alaska, Idaho, Indiana, and Washington, to meet community needs.

Though we continue to see attacks on reproductive health care, we are not going anywhere. Our staff remains steadfast in serving communities, day after day, in every single one of our six states.

Your continued financial support will ensure we can stay strong in the face of adversity, including defunding attempts and draconian regulatory barriers, and continue to be a beacon of hope for those who rely on us for their healthcare. It is harder today to sustain our operations because of relentless attacks from extremists, and we need your support.

We will keep pushing forward so future generations can exist in a world where their bodily autonomy and reproductive freedoms are protected. Together, we will continue working toward a world free from stigma and oppression.

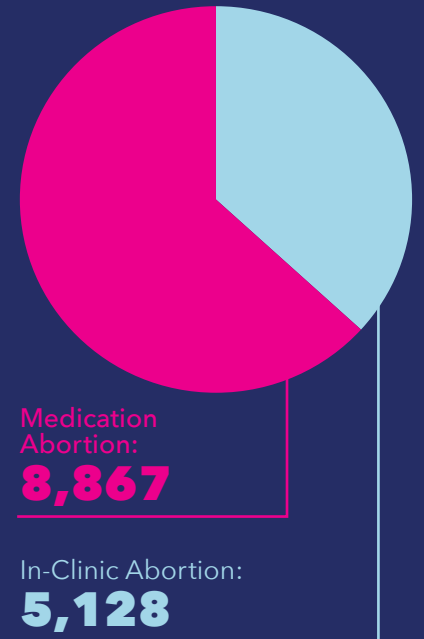
# Abortion Services

When the Supreme Court overturned Roe v. Wade, abortion remained protected in Alaska, Hawai'i, and Washington, while Idaho, Indiana, and Kentucky all enacted abortion bans by the end of 2023. Through these changes, Planned Parenthood has been a pillar of support by expanding and reimagining resources and options for care.

Abortion care is extremely time sensitive, and providing patients with timely and compassionate care is our priority at Planned Parenthood. Despite local abortion bans, patient navigators are active for all our states to help people schedule the care they need when they need it. We have increased telehealth appointments for medication abortion in Washington, Hawai'i, and Alaska. We also provide pre and post abortion care, as well as gestational dating ultrasounds and miscarriage management services across all six states.

As we continue to live without the federal constitutional right to abortion, Planned Parenthood is building accessible pathways to sexual and reproductive health care, including abortion and pre and post abortion care - no matter what.

## ABORTION ACROSS THE AFFILIATE



*"My husband and I got the heartbreaking news at our 12-week scan that our fetus had chromosomal abnormalities and would not survive. We also learned that if I attempted to continue the pregnancy, there could be significant risks to my health. To say we were devastated is an understatement. Because we already have a nearly 2-year-old son to consider, we made the difficult decision to terminate the pregnancy. Since we live in a state where abortion is illegal, we had to travel 400 miles to a Planned Parenthood to terminate. Everyone at Planned Parenthood was incredibly kind and professional, and I was able to receive the compassionate care I deserved. PP really made a horrible situation a bit more bearable because they treated us with the utmost respect and love."*

## Telehealth

Increasing access to care through telehealth enables patients to get the services they need from anywhere. Telehealth has been an important resource for the more rural and isolated geographies we serve. Telehealth increases access to medication abortion, and it also enables us to get birth control pills, patches or NuvaRings, emergency contraception, and UTI treatment into the hands of patients.



## Gender-Affirming Hormone Care

Planned Parenthood is proud to provide gender-affirming hormone care (GAHC). Access to this care is lifesaving, and we will always be here for our trans patients.

Despite the escalation of attacks on bodily autonomy, we are dedicated to ensuring access for our transgender and nonbinary patients, especially in underserved areas, and we are committed to increasing access to this care in all the states we serve. We proudly provide care to nearly one-third of all gender-affirming care patients across the entire Planned Parenthood Federation.

## Wellness For All

Planned Parenthood is a leading provider of safety-net health services in all six states we serve. Advancing health equity is our priority, which is why our health centers offer wellness and preventive care in addition to sexual and reproductive health services.

Patients rely on Planned Parenthood for sexual and reproductive health care, like cervical and testicular cancer screenings, abortion care, STI testing and treatments, contraception, and so much more. They can also visit our health centers for even more preventive care if they don't have a primary care doctor.

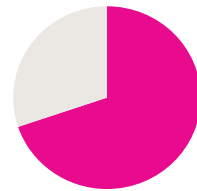
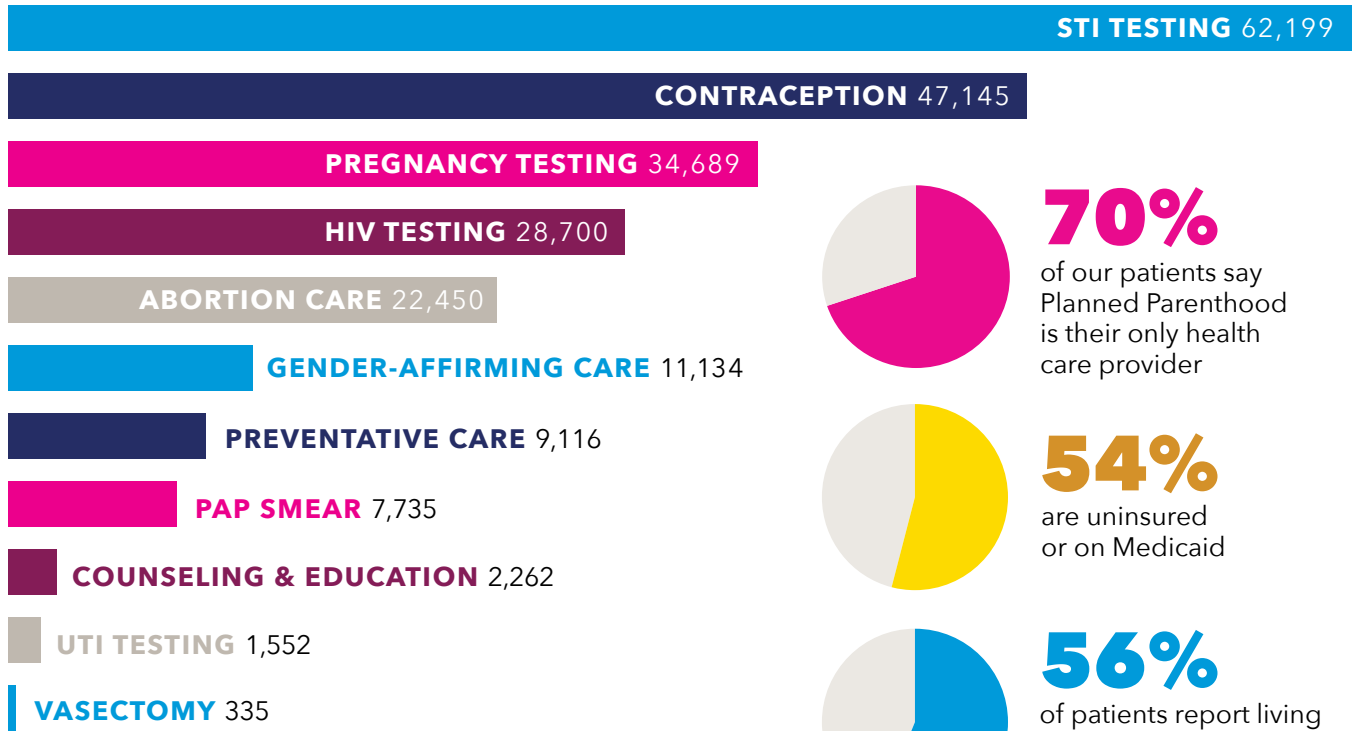
Our health centers offer wellness visits that can include screenings for anemia, cholesterol, diabetes, hypertension, thyroid, depression and mental health, domestic abuse and sex trafficking, substance use, as well as vaccinations and other primary health services patients may need.

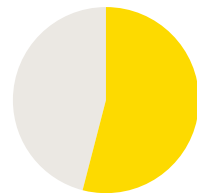

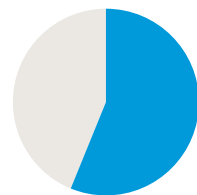

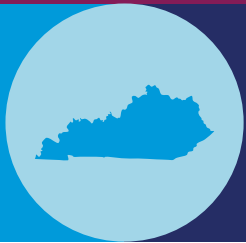

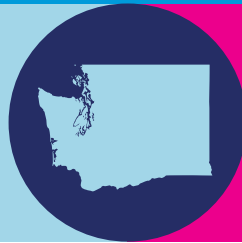

# Education

Our nationally recognized education programs increase access to medically accurate and culturally affirming resources, provide leadership opportunities, and encourage youth to be social justice advocates. We are proud to provide cutting edge programming in schools, afterschool programs, correctional facilities, and youth-serving organizations across all six states.

## IN-clued

Our IN-clued program is an evidence-based program for LGBTQ+ youth, who are disproportionately impacted by unintended pregnancy and STI rates and rarely have access to inclusive education that address the needs of LGBTQ+ youth. IN-clued hosts workshops for LGBTQ+ youth on sexual health and accessing health care, as well as for health care providers on best practices for providing care to LGBTQ+ young people. The program has been proven to decrease sexual risk taking and increase access to health care among LGBTQ+ youth.

## LiFT

Most teens say they want to connect and talk with their trusted adults about sexuality, but many adults say they feel uncomfortable and ill-equipped to have these conversations with youth. Linking Families and Teens (LiFT) is a free family program providing resources for youth and adults to communicate more frequently about sexuality and pregnancy, prevent an unwanted pregnancy, and access reproductive health care.

## Teen Council

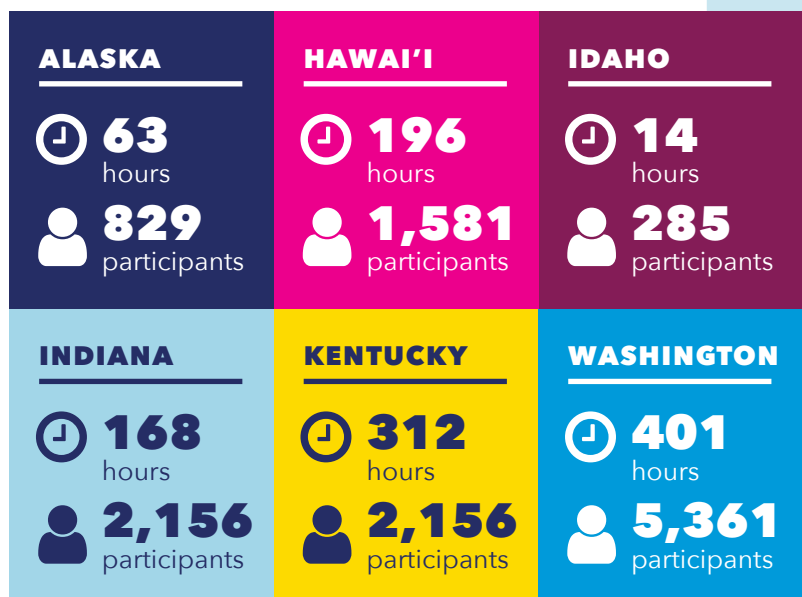
Teen Council is our peer education program that trains young people to be effective sexual health educators and social justice advocates in their community. Last year, teens across our six states met with legislators, talked to press, and presented in front of legislative committees to share their concerns about sex education bills and attacks on the LGBTQ+ community.

# Restoring access and protecting rights

After the fall of Roe, we knew lawmakers would not stop at banning abortion, and in 2023 we saw legislators turn their sights on attacking privacy, LGBTQ+ rights, and access to basic health care. Last year we saw unprecedented attacks on LGBTQ+ youth from lawmakers in Alaska, Idaho, Indiana, and Kentucky. Idaho also passed a first of its kind bill that prohibits assisting minors accessing abortion out of the state. Though we do not always stop these attacks, our teams of advocates rally at state capitols to make sure they do not pass quietly.

Our victories too have been hard-fought: In Washington and Hawai'i, legislators passed groundbreaking proactive policies protecting abortion providers and patients, and Washington devoted funding to ensure people who need an abortion can access the care they need. We will continue to push lawmakers to be bold, proactive, and aggressive in leading the nation on protecting access to sexual and reproductive health care.

Looking ahead, we will funnel our outrage over abortion bans, increased attacks on the LGBTQ+ community, and restrictions on sex education into aggressively fighting back. We will continue to grow a movement that will restore abortion rights, increase access to reproductive and sexual health care and education, and ensure all people have the right to make decisions about their bodies and futures.

Together, with thousands of supporters alongside us, we have the persistence to succeed. No matter what the extremists try to do in the political corridors and courtrooms, Planned Parenthood will continue to be here for our communities.
