

n the century since Planned Parenthood first opened its doors, we have mastered the art of fighting for the rights of our patients and communities. Some organizations would be paralyzed by repeated legislative attempts to shut them down and block access to their vital services. But we have a secret weapon – you.

This year, your overwhelming support meant we could offer patients greater access to essential health services, including expanding testing and treatment for sexually transmitted infections that pose a severe public health threat to many counties we serve. You also empowered our education teams to forge new community partnerships, rescue important programs for young people and ensure that schools can comply with California's updated sex education law.

In 2017, beginning with the historic Women's March, you and your families responded with unprecedented determination, resisting federal efforts to "defund" Planned Parenthood so

that our doors could stay open for more than 200,000 Planned Parenthood Mar Monte (PPMM) patients. You enabled us to join with other Planned Parenthood affiliates in California and work with the Governor to significantly increase reimbursement rates for reproductive health care as well as successfully lobby for a bill in the Nevada State Legislature that protects family planning funding.

What does PPMM mean to our patients? We are a safe haven for so many, like vulnerable young people, those without health insurance and even a woman who came to us with her teen daughter for treatment and protection immediately after the girl had escaped from sex-traffickers. We are an educational resource for thousands, like the teen parents who drove to one of our health centers without even a car seat for their newborn. They left PPMM with information about breast-feeding, contraceptive care, a referral to a nearby pediatrician – and carrying their baby in a new car seat.

With federal funding in constant jeopardy, it is your support that allows us to continue providing services to those who can receive this care nowhere else. In 2017, two thirds of our established donors increased their generous gifts to PPMM, and we welcomed tens of thousands of new donors as well.

Together, PPMM and our supporters persisted in the fight to improve the quality of our patients' lives and protect this indispensable health-care sanctuary. We will be sustained by the momentum and energy of all of you who have risen up to make every family a healthy family and every community a healthy community. No matter what.



The need for PPMM's preventive health care services came into sharper focus than ever before in FY17, and it will only escalate if the Affordable Care Act is repealed. PPMM met the increased demand for birth control services, testing and treatment for sexually transmitted infections (STIs) and family medicine – even as many patients feared they would lose affordable, quality care. In the first 3 months following the 2016 election, we saw a 26% increase in IUD appointments as compared to the prior period. While politicians focused on eliminating affordable health care, PPMM was busy providing it and offering a safe haven for our patients.

- PPMM participated in Santa Clara County's Primary Care Access Program (PCAP), which provided affordable health care services for uninsured low-income adults, including new immigrants who don't have health insurance.
- Our Visalia health center in California's Central Valley received Title X family planning funds that allowed us to expand health care-access in Tulare County by increasing our hours and services, including

to neighboring Kings County – which has no other resource for low-cost reproductive care or confidential health services for teens.

- Because Bakersfield and Kern Counties have extremely high rates of syphilis, PPMM is partnering with the California public health department to screen all women of reproductive age in these high-risk counties. The department has also asked PPMM to provide patients with a much-needed treatment that is unavailable at many local public health clinics.
- PPMM was one of the first affiliates to pilot online scheduling for medication abortion.
   This enables easy access for patients to book abortion appointments online, and nearly 18% of our medication abortion appointments are now booked this way.
- PPMM launched new HIV-prevention services at all of our locations with the introduction of pre-exposure prophylaxis (PrEP) and post-exposure prophylaxis (PEP), medication designed to reduce the risk of contracting HIV from an HIVpositive partner.



#### **California's STI Epidemic**

California's rate of sexually transmitted infections is at a 20-year high, disproportionately affecting adolescents and youth. Females and gay and bisexual men are also at higher risk.

In FY17, PPMM conducted over 365,000 STI tests within the California counties that are most in need of testing and treatment. Most STIs are curable and some are only treatable. But, loss of access to affordable treatment in these counties could have devastating, lifelong effects and accelerate the spread of the epidemic.





PPMM educators dramatically expanded the reach of their innovative school curriculum, tailored to California's updated school sexeducation mandate, showing again why they are a highly respected community resource. The curriculum was thoroughly revised to be inclusive of all gender identities and sexual orientations as well as all races, ethnic and cultural backgrounds.

In addition to ensuring that all students received comprehensive, unbiased sexual health education and the most current HIV-prevention information, our educators continued to promote safer sex and pregnancy-prevention as well as expand crucial outreach about testing and treatment for sexually transmitted infections in counties that have some of the highest rates of teen births and STIs in California.

PPMM educators' community outreach continued to focus on promoting positive and safe relationships, including information about preventing dating violence. The team also continued to teach more effective communication about sex and health within families and intimate relationships.

• In the past fiscal year, PPMM educators' updated curriculum was instrumental in more than doubling the number of schools they helped bring into compliance with California's sex ed law – from 19 schools in FY16 to 50 schools in FY17.

 Updated lessons in the PPMM sex ed curriculum about safety and prevention include the most current information about relationship-abuse and sex-trafficking. The lessons also feature a renewed focus on healthy behaviors and communication, including time allotted to discuss active consent.

- In Santa Clara County, PPMM's Education caseworkers and the Public Affairs department played a key role in the establishment of the new Teen Parent Support Program (TPSP), which the Board of Supervisors agreed to fund after the local program lost state funding in FY17.
- Educators forged new community partnerships with other safety-net providers, conducting workshops for local homeless families and individuals, teen groups, senior citizens, and those with intellectual disabilities. Educators also hosted education and resource events that benefitted our Teen Success group members and their families.
- PPMM provided professional training to over 700 people who work with youth on how to have open conversations about puberty, safe sex and healthy relationships.
- Peer educators and Promotores, volunteer youth and young adults trained by the PPMM Education department, were instrumental in extending our outreach capacity. This included Peer Educators making school presentations and hosting the first Education social media "Tweet Up," highlighting Get Yourself Tested (GYT) Month.

 Ella\*, mother and advocate, San Jose, CA During the most formidable congressional attacks against Planned Parenthood in a generation, PPMM's Public Affairs team launched a strategic advocacy plan with thousands of supporters in California and Nevada to stop legislation that would repeal the Affordable Care Act (ACA), decimate Medicaid and eliminate funding for Planned Parenthood.

Spurred by the national Women's March, a political awakening that marked the beginning of a powerful grassroots resistance, more than 170,000 PPMM supporters in California and Nevada mobilized at rallies and legislators' town hall meetings to oppose federal legislation that would leave the great majority of our patients without health care.


In California, we worked with other affiliates, lawmakers and the Governor to significantly increase reimbursement rates for Medi-Cal, the state's Medicaid program. In Nevada, we partnered with coalition groups to help pass a law that protects preventive health benefits provided to women through the ACA. This legislation was signed by governors of both major political parties, an encouraging display of bi-partisan support for family planning in the two states we serve.

- In FY17, years of tireless advocacy with the California affiliates helped lead to a significant state budget increase in reimbursement rates for medical services, including \$50 million for women's health care.
- PPMM, in coalition with community partners in Nevada, played an instrumental role in the creation of a state grant program that will establish funding for family planning services – including in rural Nevada – if the ACA is repealed.
- In FY17, PPMM partnered with more than 100 organizations and groups to fight federal attacks on reproductive justice policies. We stood in solidarity with labor, communities of color and new immigrants to protect access to affordable health care, immigration, affordable housing and bans on carcinogenic pesticides near schools.
- In February, more than 6,300 PPMM supporters counter-demonstrated against 228 protestors at 16 PPMM health centers in California and Nevada, showing the power of PINK.

## Patients in PPMM Service Area Rely Heavily on Medi-Cal

Eleven of the 16 California counties that PPMM serves are heavily dependent on Medi-Cal and benefitted from the Medi-Cal expansion Act under the Affordable Care Act. Counties including Tulare, Merced and Fresno, that have more than 50% enrolled in Medi-Cal, would be the hardest hit by Medi-Cal cuts and loss of access to our services. Although Nevada Medicaid enrollment grew by 90% as a result of Medicaid expansion, reliance on Medicaid in Nevada is low relative to California.





# PANNED PARENTHOOD

PPMM Supporters are patients, donors, staff, volunteers and community partners. We all have our own story and our own personal connection to Planned Parenthood. As vital members of the PPMM family, we care deeply about our patients, our staff and our mission.

In FY17, supporters expanded PPMM's impact in our communities through virtually every department of the affiliate. You stood with our patients as volunteer escorts, extending a comforting arm at health centers to those who came to us for care. You made all the difference at special events, including the Peninsula Breakfast and the Roe Luncheon. You were our ambassadors at Pride parades and regional fundraisers like the Human Race in Santa Cruz.

Volunteer photographers supplied the marketing team with high-resolution images of our health centers and PPMM events. Groups of dedicated seniors knit hundreds of pink Power Hats for us to exchange for donations, and volunteers stepped up to deliver cakes to health center staff for Planned Parenthood's centennial birthday celebration.

Staff volunteers and peer educators participated in outreach at dozens of events sponsored by our ardent supporters. PPMM supporters hosted house parties, business events, art auctions and performances, with proceeds benefitting our affiliate and patients. Some of you volunteered to help out with administrative work in our health centers and even to drive Pride parade floats!

Together, we persisted despite those who would eliminate our trusted, essential care – and our supporters inspired us every day. We all stepped in and stepped up to keep PPMM strong in FY17.





## Of the 217,278 patients served by PPMM in FY17:


- 71% live below 100% of the Federal Poverty Level (2017 FPL annual income for one person is \$12,060)
- 94% live at or below 200% of the Federal Poverty Level
- 45% are insured by Medi-Cal
- 38% are covered by California's Family PACT (Planning, Access, Care and Treatment) program, which provides contraceptives for those living up to 200% of FPL, and who don't have ACA insurance.


