Message from Our Leadership

In fiscal year 2021, amid myriad attacks on reproductive freedom, and the persistent challenges of the pandemic, access to affordable sexual and reproductive health care and comprehensive sex education were more critical than ever. We never wavered from the critical priority of meeting our communities' needs safely. We continually prioritized access, and implemented new services to reach vulnerable populations with the greatest need.

Our Patients Services team made innovations in our health care delivery, combining in-person visits with new telemedicine services, devoting resources to further utilize these services, along with digital advertising to promote them.

PPSP's Education staff moved quickly and with exceptional creativity to deliver all of our current programs. Our advocacy staff also worked through digital platforms, coordinating with our state and national offices to protect telemedicine, abortion access and patient dignity.

Patients and staff deserve to visit our health centers safely, free from harassment and intimidation. Yet, during the pandemic, we have seen an increase in aggressive protest activities and deliberate, illegal tactics to impede our health center operations, intimidate our staff, and prevent patients from receiving care. The Pennsylvania legislature consistently leapt at the opportunity to further control people's lives by introducing bills aimed at severely restricting the rights of those seeking abortions. Our External Affairs Department battled a slew of anti-abortion and anti-reproductive health legislation, and worked to educate and galvanize our supporter base and our champions in the Pennsylvania legislature.

The pandemic continued to highlight the inequities in the healthcare system. We embraced our responsibility to advocate for racial and social justice and centered racial equity for our staff and the communities we serve.

The courage, resilience, and perseverance of all of PPSP's staff remained inspirational. We were heartened by how strongly our supporters stood with PPSP; and our patients and communities and were unwavering in their engagement and generosity. Our efforts in fiscal year 2021 have poised us to continue building back in 2022. You know that we will continue to be unrelenting in our fight for sexual and reproductive health, rights, and freedoms.

Patient Services

Our Patient Services Department provided excellent patient access to care throughout the year. Our pivot to telemedicine during the initial wave of COVID-19 in 2020 poised our health centers to continue to meet the challenges of the evolving pandemic.

Throughout FY2021, we made innovations to our health care delivery. All health centers integrated video and phone-based telemedicine into their daily schedules while adding back in-person care. We increased appointment availability each month, returned to online-appointment scheduling, and welcomed in-person visits.

As always, we remained committed to centering the patient experience in all aspects of our operations. To this end, we achieved the following in fiscal year 2021:

- In our fourth year of offering gender-affirming care, we expanded appointment access by centralizing operations and staff support. We provided gender-affirming hormone therapy initiation for 262 new patients and provided nearly 1,400 gender-affirming care visits.
- Our Abortion Centers continuously ensured access to time-sensitive care with no interruption in services since the beginning of the pandemic. We modified physical spaces and altered our care delivery, removing barriers to abortion care while also reducing the number of patients physically present in our health centers. We provided low-touch medication abortion follow-up using home pregnancy testing and continued offering telemedicine medication abortion visits, serving 350 patients. Phone-based, pre-abortion counseling remains popular, with 90% of our patients receiving their information sessions via phone in fiscal year 2021. We also expanded online appointment scheduling to include abortion services, and patients can now book their phone-based information sessions and abortion appointments online.
- We upgraded our audio-only, telephone-based interpretation services to on-demand video interpretation systems at all health center locations. The new service connects patients with high quality, professional interpreters in over 250 languages and American Sign Language - empowering all patients to make fully-informed health decisions.
- Our Marketing Department reached communities across our four-county service area with digital advertising campaigns about our expanding range of safe, convenient services. We boosted our online presence with the addition of TikTok as one of our digital advertising platforms. We were also one of five affiliates selected to participate in Planned Parenthood's national "Be Seen" online marketing campaign, focused on elevating the voices of BIPOC communities.



Education

PPSP's Education staff continued to adapt to the changing educational landscape caused by the pandemic. We remained a trusted partner to those we serve, delivering our programs through digital platforms and maintaining connections with students, schools, and communities during a challenging time. In addition, we utilized technology to enhance our programming, developing innovative, participant-led workshops to deliver more dynamic sexuality education.

- We provided flexible learning options to maximize our impact, reaching close to 1,200 individuals through our comprehensive suite of sexuality and reproductive health education programming. We also made 26 new contacts with schools and community-based organizations and distributed more than 21,852 safer-sex materials.
- In FY2021, our Community Education staff continued to exclusively provide online programming, collaborating with schools and stakeholders to deliver lessons in creative ways. We reached 1,089 young people through 292 sexuality and reproductive health education workshops. We also worked with our partners to prepare programming responsive to their needs for online, in-person, and hybrid delivery in the 2021-2022 school year.
- We resumed programs for youth-serving professionals in FY2021, reaching 102 adults. We launched a new webinar series to help deliver essential information and skills to adults who work with young people. Topics included Trauma-Informed Sex Ed, Affirmative Consent, and Working with LGBTQ+ Youth. These sessions connect our Educators with others working in the field and promote PPSP as a leader in our region for inclusive, comprehensive sexuality education.
- Space to be Proud, Open, and Together (SPOT) and Rainbow Phoenix served as safe spaces, support groups, and social networks for LGBTQ+ youth in Chester County. We hosted 50 mostly virtual meetings, reaching 16 participants with social activities and affirming sexuality and reproductive health education. We supplemented our offerings with an array of programs designed to meet the unique needs of our participants, including discussions of post-high school and college experiences and programs on strategies for coping with trauma.





External Affairs

Amidst the parallel challenges of COVID-19 and a blitz of anti-abortion legislation, the External Affairs Department maintained its ability to inform and mobilize supporters. During fiscal year 2021, we strove to rebuild volunteer programs to support patients and health services, and to reinvigorate our advocacy work by engaging and educating communities.

The Pennsylvania House Health Committee held over nine hours of hearings on abortion access and funding in the Commonwealth. The External Affairs team worked closely with Planned Parenthood Pennsylvania Advocates (PPPA) staff and partner organizations to prepare testimony and educate supporters in response to harmful misinformation and anti-abortion rhetoric from anti-abortion lawmakers.

Emboldened by the Supreme Court maintaining Texas' harmful S.B.8 and agreeing to hear *Dobbs v. Jackson Women's Health* (Mississippi's 15-week abortion ban), the Pennsylvania legislature was introduced multiple bills aimed at removing access to abortion services across the Commonwealth. This legislation includes S.B. 956—a constitutional amendment that, if passed, lays the groundwork to outlaw abortion in Pennsylvania.

We revamped our patient escort program in four health centers.

We continued to cultivate this program, by expanding leadership and advocacy opportunities for volunteers. And thanks to an influx of new volunteers from groups like Temple University's Women's Law Caucus, we added escort shifts on more days at Center City and West Chester Health Centers to support patients amidst increasing anti-abortion and anti-Planned Parenthood protests. We also created a plan to restore additional in-person volunteer opportunities - including the Patient Advocacy Program and Storytelling initiative, with both programs seeking to recruit volunteer leaders from BIPOC and youth communities.

During fiscal year 2021, our volunteers stepped up for our patients in extraordinary ways, including:

- More than 40 volunteers escorted patients at health centers that offer abortion care in Center City, West Chester, Norristown, and Far Northeast Philadelphia.
- A total of 294 shifts - 675 hours (and counting!) - have been completed by our steadfast volunteers.
- Plus, we onboarded 92 PPSP general volunteers in fiscal year 2021.

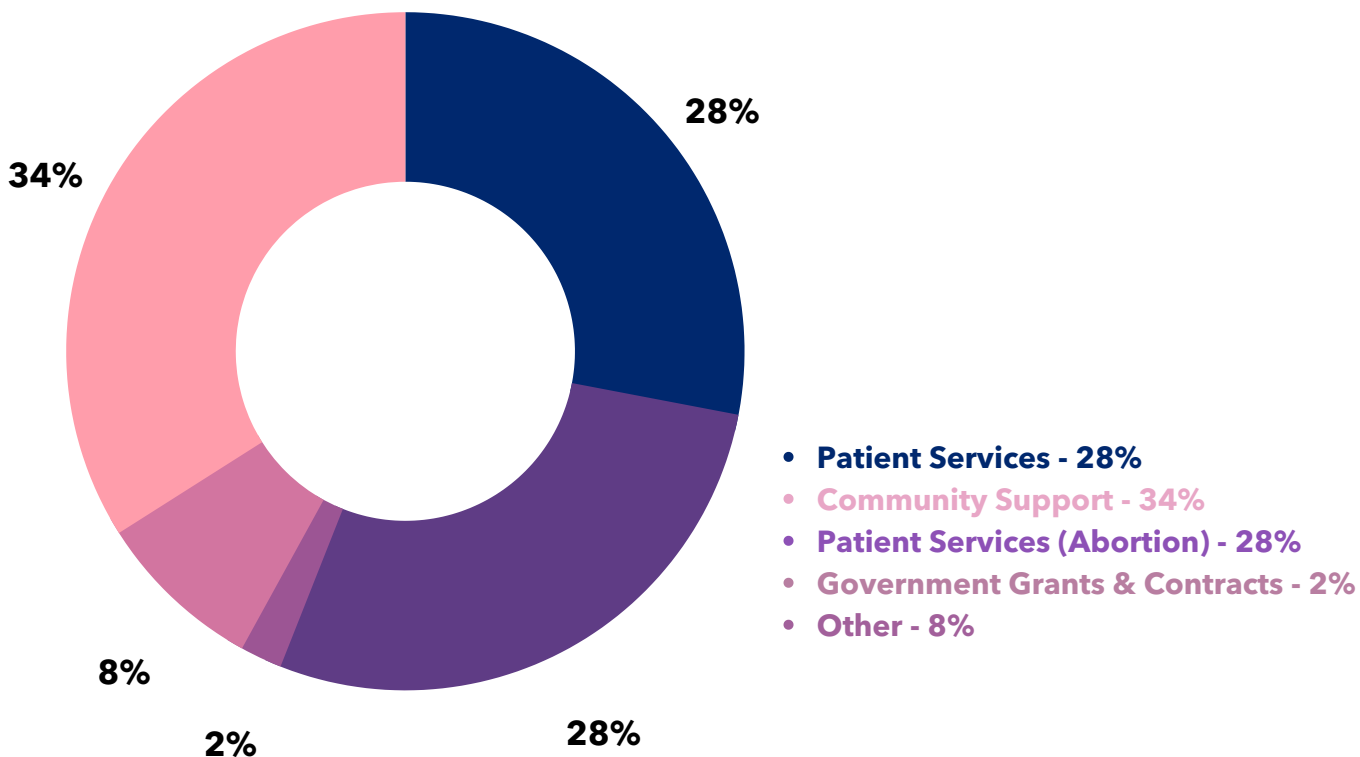
We led advocacy work on issues of critical importance to our patients and constituents, including:

- We continued to collaborate with coalition partners as part of the Campaign for Women's Health and the PA Coalition for Sex Education, uplifting and responding to attacks on sexual and reproductive health while supporting other social justice issues facing PPSP communities.
- We worked in partnership with PPPA to hold a legislator convening with focuses on anti-abortion legislation, "crisis pregnancy centers" and Real Alternatives, and sex education in Pennsylvania. And we continued to educate lawmakers on issues of sexual and reproductive health access and rights.

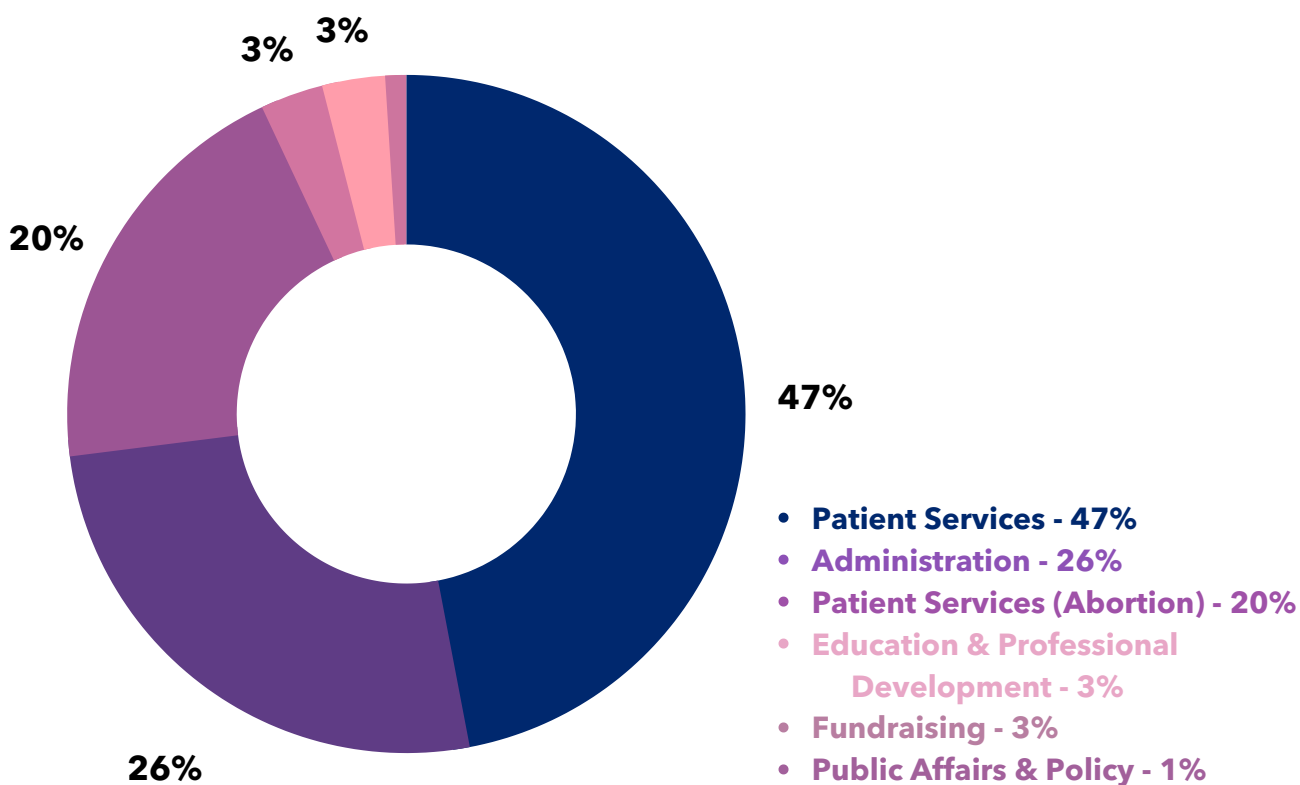


Fiscal Year 2021
