Please let us know of your intent to give. We will alert our account manager at Merrill Lynch to expect it. You should also notify your broker or personal financial advisor of your plans to make this gift. If your broker holds the stock certificate, then they will handle the transfer of the certificate and stock to PPMM's account at Merrill Lynch.

If you hold the stock certificate personally, you should check with your broker as to their recommendation on transporting that certificate to Merrill Lynch.
